

Minutes of the 157^{th} Meeting (Part I)

February, 2 2023

The meeting was started at 11:25 a.m. by moderator Hallie Hodgins who provided the rules for voting when using Zoom.

Pastor Michelle welcomed all with "99 prayers your church needs but doesn't know it yet". Through the Cottage Meetings she has seen how members of the congregation have coped and moved forward. PCC is resilient! Seeing so many in attendance makes her happy. Pastor Michelle offered a prayer for the unsustainable budget and asked for help.

Hallie thanked the members for attending the business meetings that have been held and Pastor Michelle for her dedication to PCC. She asked that everyone keep an open mind during discussions. Strategies will be discussed later in the meeting.

Pastor Michelle provided a scripture passage from Isiah 40:31.

The congregation was invited to sing the first three verses of the hymn of the church "I Love Thy Kingdom, Lord."

Hallie indicated that the Bylaws state that the Annual Meeting is to be held in June but now that our fiscal year is aligned with the calendar year it should be changed to February. It was voted to change.

The meeting was called to order at 11:34 a.m. and a quorum was confirmed by the Clerk.

A motion to accept the Minutes of the 156th Annual Meeting of the Plantsville Congregational UCC was made by John Christiance, with a second by Cindy Cayer. There was no discussion, and the minutes were accepted as written.

A motion to accept the minutes of the September 25, 2022, special business meeting to establish the Pastoral Search Committee was made by Alan DeBisschop and seconded by Tony Senatore. There was no discussion. The minutes were accepted as written.

Treasurer's Report – motion to approve made by Barbara Mackay seconded by Liz Douglas Discussion: Glenn Fortin said that the \$1,000 that is supposed to be moved from both the Charlie and Ruth Atwater Reserve never occurred. Paul Kulas, the Treasurer, will do it this year. The Treasurer's report was accepted.

Staff Reports:

Will not review each report unless there is something that needs to change or specifically be pointed out. There is no need to vote to accept the reports of the Boards and Committees. Discussion:

Liz Douglas – Registrar Report on page 14 there is an error. It should be Greg and Joan Schmidt not Linda.

Pastor Michelle asked if Pastor Paul's membership had been transferred to another church and no knows. Pastor Michelle will follow-up on this.

Karen Forster – changes to Nominating slate:

Christian Action: Linda Lindsay said that all members going off in 2023 are extending to 2024

but are unsure about Jane Gutowski.

Christian Education: Doris Lipetz extending to 2025.

Memorial Garden Board: Sarah Cohen to 2025.

Wendy Fortin extends from 2023 to 2025.

Deacons: Nancy Pasco goes off 2022.

Marilyn Walter extends to 2025.

Bill Leary extends to 2025.

Music: Mike Giuffrida extending to 2025.

Remove Michael DellaVecchia.

At Large: There is no one.

Library Committee: Per Joyce Buckley – this is no longer a functioning committee. Pastor Michelle said that if the committee is struck from the Nominating Role it can be re-established if needed per the bylaws. Karen Forster said that the current names will be removed but that the committee will not be dissolved.

Kitchen Committee:

Per Karen Forster this should be renamed to Hospitality Committee since its purpose now is mostly for coffee hour setup.

The question was asked whether we still need to have a Kitchen Committee?

Gail said that the Committee was formed to get supplies and to clean the counters and keep them clear of "stuff." Nancy Pasco said that duties were to clean and stock supplies.

Tony Senatore and Glenn Fortin have been doing deep cleaning for large events and will continue to do this. Sue Smayda said that we should have an Ad Hoc Kitchen Committee for times like this to be filled as needed.

Liz Douglas said that the Hospitality Committee cleans up after Sunday use and they watch supplies.

Alan DeBisschop wanted clarification. The Deacons will be hosting three dinners in March. Whose responsibility is it to make sure that there are enough supplies (plates, napkins)? Answer – the Board/Committee holding the event.

Safe Conduct:

Is this still being done? Pastor Michelle said 'Yes.' May be affected by Bylaw revision.

Audit Committee:

How many members are needed?

SNEC and Central Association Delegate – John Christiance is no longer on either Sue Smayda asked if the Bylaws Committee should be added as a special Committee. Sue made a motion to create a Bylaws Revision Committee. The members are Doris Lipetz, Linda Lindsay, Sue Smayda, Diane Pisko, and Pastor Michelle ex officio.

Tony Senatore made a motion to accept the Nominating Slate with amendments, seconded by Glenn Fortin.

Discussion: John Smayda said that it would be nice to get a Youth Delegate to represent PCC and one Adult.

The motion passed.

The Proposed 2023 Budget presented by Linda LaForge.

When doing a full year budget for 2023 it was a deficit budget of \$56,000.

Linda made a motion to continue the meeting to June 4, 2023, and to consider the concept of a 6-month budget today.

Alan DeBisschop seconded the motion.

Discussion:

Pastor Michelle said that the Budget Committee and members who attended the meetings elected to create a 6-month budget for time and for restructuring/fundraising.

Pastor Michelle asked the question –

This will be an ongoing meeting.

Alan DeBisschop said pledging is up, interest rates are down, but costs have risen.

A letter was sent out to request a one-time donation or an increase in pledge amount. Doris was asked how much extra money this brought in. Doris' best guess was \$10,000.

John Smayda noted that the PPE got us through one year.

Cindy Cayer said that from the perspective of the Search Committee having this extra time will help them complete the profile and conclude their work.

The motion passed.

Linda LaForge made a motion to accept a 6-month budget from January 1, 2023, through June 30, 2023. John Christiance seconded the motion.

Discussion:

Doris Lipetz wanted an explanation of how the deficit for the first six months was closed. Linda said that on page 2 of the budget there was a box showing the fund transfers for which approval

would be requested. The Trustees were careful when reviewing the funds; the largest amount is from the Fair Fund. These monies would only be used if necessary.

Glenn Fortin said that the \$6,000 offered from the Julie Fortin Scholarship fund given by Glenn and Wendy Fortin is still a church decision.

Greg LaForge asked for clarification on salaries. Linda explained that there was a 3% increase for the Christian Education Director and the Director of Music. There was no increase for the Office Administrator because she was recently hired. No increase for the Interim Minister because she is still in her annual contract.

Doris Lipetz- questions taking money from the church scholarship fund when per the bylaws all the money is meant to go toward education. Glenn Fortin response was that Doris is correct, however do we want to keep the church going? We are only asking to take 4%, If the church closes, then there is no more need for the fund.

Doris – how come nothing is being taken from the Tent fund? Glenn's response – the tents are currently used for the Fair. The tent fund is needed to repair/replace to make that part of the Fair viable.

Gail Shaw asked about the Restricted Funds and whether we can take from those since there is a lot of money there. Glenn said that we can only take interest as requested. Would need legal advice to know what we can do. Also, if we decrease the principal then we decrease our yearly investments.

Sue Smayda asked if the tent was in good shape for the coming year and Tony Senatore said yes, although there could be unforeseen destruction, not just wear and tear.

Glenn said that he could argue that the Julie Fortin scholarship should be treated just like the PCC scholarship.

Vote on 6-month budget. One nay; motion passes.

Greg LaForge asked a question in regard to the 6-month budget. What do we do during these six months? Should we be doing our due diligence to find creative ways to make money so that we do not have to touch the temporarily restricted funds?

Old Business – No

SPRINT – Hallie explained and provided a handout.

5 Groups – there is a description of each to help you decide which to join.

Every 3rd Sunday – give a check-in of when you meet and what your group has accomplished Use SNEC for resources and ideas. Michelle will guide you to resources beyond our church.

Boards/Committees – propose having no meetings in March.

Need a minimum of four people on each of the five teams to make them run effectively.

John Smayda asked if there was a definitive timeline. Pastor Michelle said it would end in May with update provided in March/April. Proposal to be provided on May 21st so the Trustees can finalize the second half of the budget for July through December.

Hallie made a motion to create short term groups. Sue Smayda seconded the motion.

Discussion:

Meetings need to start soon – within next two weeks.

Signup sheets are on the stage. Alan reminded people to provide their name, telephone number, and email address.

The motion passed.

Sue Smayda made a motion that the five teams will convene within two weeks and assign a chairperson. Tony Senatore seconded the motion. There was no discussion. The motion passed.

Sue Smayda gave a thank you to Mike Giuffrida for providing one and a half years of sound and visual.

Moderator Hallie Hodgins made a motion to adjourn the meeting at 12:50 p.m. and reconvene on June 4, 2023. Tony Senatore seconded the motion. The motion was approved.

The congregation sang verses 4 and 5 of "I Love Thy Kingdom, Lord".

Pastor Michelle provided a closing prayer.

Minutes of the 157th Meeting (Part II) June, 4 2023

The meeting was re-opened at 11:17 a.m. by moderator Hallie Hodgins. Hallie thanked the SPRINT groups for their proposals – some of which will need to be voted on and others that do not need a vote.

Motion #1: made by Hallie Hodgins, seconded by Sue Smayda.

Leave the position of Church School Director vacant for the upcoming fiscal year and initiate a volunteer Sunday School program.

Discussion: Sue Smayda – if passed, it will rely on volunteers to work on the program and also more volunteers to join the Board of Christian Education; Pastor Michelle asked those that commit to assist to raise their hands agreeing to participate in future planning, to be on committees, teaching, etc. She took a picture of the group for future reference. The motion carried.

Motion #2: made by Hallie Hodgins, seconded by Alan DeBisschop.

Have the PCC youth group (PYF) join the already established youth group at First Congregational Church (FCC).

Discussion:

This also requires volunteers. Initial conversations have been had with FCC. Waiting for our decision. It was asked if there was any cost? There is no initial cost. There may be a need for chaperones and snacks. There may be some costs down the road if the group becomes larger. It's a good idea to merge to increase size but there are concerns about potential impacts such as

families leaving PCC and going to FCC. This is not just FCC and PCC, it's several churches in combination and the meetings will be held at each church – how to alternate is a challenge. Motion carried.

Motion #3: made by Hallie Hodgins, seconded by Cindy Cayer.

Establish a committee to interview (five members with a maximum of two Trustees) and to potentially hire a Certified Financial Planner (CFP). A minimum of three Certified Financial Planners should be interviewed.

Discussion:

Nancy Pasco stated that in the past a Financial Planner/Fundraiser was hired and the percentage that they took was almost as much as was made. Would we gain enough to make it worth it? What would be the percentage that they would take? John Smayda said that the average fee is 1%. Hallie said that the CFP will look at the books to see if PCC should diversify. The hope is to get higher returns so that we increase our investment income.

Cindy suggested that the motion be amended so that an open meeting can be called where the Council has final approval of the recommendation once the person has been selected. Sue Smayda seconded the amended motion.

Alan asked who would establish this committee. Hallie said that Council will ask members to join.

Motion carried.

Motion #4: made by Hallie Hodgins, seconded by Tony Senatore.

Combine all major fundraising income into the budget

- 1. An established amount shall be allocated for capital expenditures.
- 2. Seed money for fundraising to be added as an expense to the budget.
- 3. Targeted fundraising, approved by Council, shall not be included into the budget.

Discussion:

What are targeted fundraisers? Bake sales, casserole sales to support specific Boards or Committees; monies from major fundraisers such as the Fair and Play will go into the general fund.

This will start will the 2024 budget and is not changing any of the current reserves. Motion carried.

Motion #5: made by Hallie Hodgins, seconded by Bill Leary.

Form a Technology Committee to coordinate and expand digital ministry (stream, sounds, social media).

This was handled at Council but is open for discussion.

Motion #6: made by Hallie Hodgins, seconded by Cindy Cayer.

Establish a committee to recommend a mission/vision statement for church approval.

Discussion:

Dan Nardini asked if the Search Committee needed this to complete the profile. Cindy said no but it would be useful. Amend the language to revise.

Motion carried.

Motion #7: made by Hallie Hodgins, seconded by John Smayda.

Set aside \$5,000 this fiscal year to enhance our website and social media presence.

Discussion:

Tony Senatore said that a vision needs to be created and brought to Council. Cindy Cayer said that we should strike the motion. Let the Tech Committee do some research and come back with a proposal.

All opposed the motion.

Pastor Michelle said that with motions #1 and #2 being approved, the Board of Christian Education, Council and Staff will plan for a more substantial thank you as Devin is willing and able to participate.

Linda LaForge presents 2023 full year budget.

Minor change from Alan DeBisschop. Line 5103 (Central Assn) should be only 222 members for a \$140 decrease.

Changed the Minister's Package to 3/4 year for interim and 1/4 year for settled pastor. This is reflected in the \$97,513 package total.

The cost for snow removal decreased because we had such a mild winter.

Christian Education position will be vacant for second half of year. So, \$5,665 is not needed and is reflected in amount budgeted.

Will draw from the temporarily restricted funds only if needed.

Sue Smayda made a motion to accept the budget, Cindy Cayer seconded.

Discussion:

Alan DeBisschop noted that he posted the Mystery Dinner profit on the bulletin board in Fellowship Hall, kept \$1,500 for next year's dinner seed money.

Sue Smayda thanked Linda for all the work on the budget.

Diane Pisko asked if it had been decided how money would be taken from the temporarily restricted funds if/when needed? Tony Senatore said that was not decided. May be a percentage from each fund. The decision would most likely be made by Trustees and Council.

Cindy Cayer said that she hopes all other funds given from Christian Action will continue to be supported.

The motion carried.

Linda LaForge presented a preview of a 2024 budget showing the potential deficit if we hire a full-time settled pastor.

Cindy Cayer said that the Search Committee is waiting for direction from the Trustees on what they can offer for a minister's package.

Cindy made a motion that for a 3-year period we use the funds from the unrestricted endowments to cover any deficit and pay a full-time pastor, if needed. Sue Smayda seconded the motion.

Discussion:

Nancy Pasco said that this was a dangerous road to go down.

Alan DeBisschop asked if we know what percentage we are currently getting? Glenn knows (but is not in attendance) – guess is probably around 5%

Tony Senatore said that we might be able to rent out the parsonage.

Hallie said that we need to give a guarantee to a new pastor.

Linda LaForge stated that the Minister's Package shows the pastor using the parsonage. If they do not use it, we would have to pay a housing allowance of at least \$18,000.

Dan Nardini asked if we are looking into the legality of using funds from families no longer around.

Sue Smayda said that we need to continue to pursue the ideas identified in the SPRINT groups that can generate income.

John Forster had a concern about an Industrial Appraisal because every item will be itemized and will be paid for in insurance coverage. Linda LaForge said that she spoke with our agent, and he suggested that we do an Industrial Appraisal as it may lower our premium. Also, all the new tech equipment is not included at this time.

Corrine Watts asked if we had a part-time pastor wouldn't we still have to pay for subs? Pastor Michelle said that if a part-time pastor is hired then a lot of the things that the pastor would do will fall to the members. For example: lead class, do home visits; would need leadership from the congregation. Or members can save the church money by cleaning the building, doing snow removal, etc.

Andrew Larkin asked if we could just get a teenager to do the lawn care.

Vote on Cindy's motion; one opposed, one abstained, motion carried.

Hallie asked for a motion to close the 157th annual meeting of Plantsville Congregational Church.

The motion was carried, and the meeting adjourned at 12:13 p.m.

Minutes of the July 19, 2023 Special Business Meeting

The meeting was called to order at 7:01 p.m. by Moderator Hallie Hodgins.

The purpose of the meeting was to consider the original motion made at the continuation of the annual meeting on June 4, 2023, "that for a 3-year period use funds from unrestricted endowments to cover any deficit and pay a full-time paster if needed".

It was determined that this motion could be supported by the amount of funds in the Unrestricted Endowment Fund at that time. But we have since learned that that fund is not a static account. It fluctuates with the stock market.

Glenn Fortin, who was unable to make the June 4th meeting, provided those in attendance with an explanation of how the endowments work and how that particular account is funded. At present,

there is \$39,280 in the Unrestricted Endowments due to market fluctuations but is expected to go up because the market went up in June.

To do our due diligence, the Budget Committee asked Dan Nardini to do an independent verification of all the amounts in all accounts and they are all accurate. Glenn will make himself available to review accounts with anyone should they want to do so.

There were no questions.

Cindy said that the Search Committee needed to have a Financial Package ready in two weeks.

We can price differences between full-time, 3/4-time, 1/2-time and see what the cost savings would be. Reducing from full-time (40 hours) to part-time (20 hours) per week saves approximately \$35,000 per year. We can offer any package at any price to see if we have any takers. Straw poll – should we move ahead with a full-time pastor? Tony Senatore said that was the original goal.

Discussion:

Glenn Fortin said that part-time is 50% of salary, medical, and housing. We should not just look at cash. We can offer anything that we want.

Dan Nardini asked where the Search Committee was in the profile process and was told that it was 98% done, just waiting for this decision to be made. Once completed by the Search Committee, Pastor Michelle will do a read-through, then it will go to the Conference for their approval and will go out for posting in mid-August.

Cindy said that as soon as the profile is done and posted the Search Committee will let the congregation know and will provide it to the congregation.

Do we choose to move forward with a full-time or part-time pastor? It was decided to stand behind the original motion. Therefore, if no one wants to change to part-time then no vote is needed and the original motion stands.

It was agreed that the Memorial Garden Board bake sale would not affect the Christian Action "Fill the Truck" event.

Aubrey Quinlan has a wish list for Sunday School on Amazon.

Pastor Michelle provided a closing prayer.

The meeting was adjourned at 7:26 p.m.

Report of the Interim Minister

As 2024 begins and my interim ministry with you concludes, I am thinking about "technical" versus "adaptive" change.

Technical change in a church is when individuals respond to address a situation; it feels like "solving a problem." An example at PCC would be the Budget Process in January 2023 in which Board and Committee representatives cut expenses and allocated funds from their accounts to try to address the deficit, or the Ye Olde Country Fair Committee shifting rooms around after a car accident made two downstairs spaces temporarily unusable.

Adaptive change in a church happens when the membership collectively engages in a longer-term process to re-envision its existence for mission in an altered world; it feels like "transformation." Signs of this kind of change at PCC might be understanding resources as a means to ministry rather than maintenance, or the congregation primarily measuring programs' success by the number and quality of new relationships formed as opposed to the enjoyment of current church members.

It will take time for PCC to determine whether the work the church began in 2023 is 'adaptive,' but I am hopeful that good groundwork for renewal has been laid by the Spring 2023 SPRINT Groups initiated by Moderator Hallie Hodgins as well as simultaneous and subsequent creative conversations and program experiments in the congregation.

PCC's revitalization efforts were furthered in December by the Pastoral Search Committee's recommendation and the congregation's call of a new settled pastor with experience in church growth, the Reverend Jane Willan. Many thanks to Cindy Cayer and her team for their hard work, patience with the congregation's process, and skillful discernment!

Given that change already involves grief, I have been concerned about the volume of loss PCC experienced in 2023, with eleven funeral and memorial services I conducted at or on behalf of the church, most during the last few months of the year. I drew encouragement that, through God's grace, the year also gave opportunities to celebrate new life and faith, as PCC welcomed a new member and witnessed four infant and one adult baptisms.

A personal highlight of the year for me was the opportunity to be on stage with "Buttercup" and all the denizens of King Cole's realm in May. I am very grateful to the congregation for supporting my partial leave to attend to family matters in July, and wish to especially thank my staff mates Marilyn Cannata and Jill Battaglia (and Devin Van Patten through June) as well as numerous faithful volunteers for accommodating my time "working from Texas."

As I leave this ministry at the end of January 2024, I pray God's continued blessing on PCC and the friends I leave behind here in Plantsville.

Report of the Pastoral Search Committee

The Pastoral Search Committee members are: Cindy Cayer, Chairperson, Charlotte Camilleri, Communication, Taneta McCaw, Chaplain, Bill Leary, Technology, Alan DeBisschop, Secretary, Barbara Mackay, and Herdean McCaw. Sadly, Herdean passed away on November 18, 2023.

Reverend Isaac Lawson, the Area Conference Minister for the Southern New England Conference was our representative who was available for guidance throughout the process.

The Search Committee officially began on October 12, 2022, and on November 20, 2023, concluding our prayer-filled process of reviewing profiles and interviewing candidates, announced that Reverend Jane Willan was our candidate of choice to become the 19th minister of the Plantsville Congregational Church.

The creation of the church profile took place throughout the year with important input from the Congregation as to what it desired in a church minister. Answers to the following questions needed to be included: Who is God calling to minister with us? Who is God calling us to become? Who are we now? Who is our neighbor? The Search Committee held 24 official meetings and the church profile was published on the Conference website in August, 2023. Twelve candidates applied for the position. Several were interviewed online. Several were interviewed twice, and the committee met two in person. There was an opportunity to watch candidate sermons online.

An opportunity for the Congregation to meet Rev. Willan was held on Saturday, December 9, 2023, at a Meet and Greet Mocktail Party in Fellowship Hall. Rev. Willan led the worship service on Sunday, December 10, 2023. A Congregational Meeting was held following worship. The Congregation had the opportunity to ask questions of the Search Committee followed by a vote in person, on Zoom and YouTube. By unanimous vote, the Congregation called Rev. Willan.

A Call Agreement was signed and accepted by both the Church and the elected candidate. Reverend Willan will begin her duties on Monday, February 4, 2024. She and her husband will move into the Parsonage during the month of January.

Throughout the year, the chancel choir continued to deliver beautiful music, presenting anthems, hymns, and special pieces. Christian Education Board

During 2023, the Christian Education Program endured the loss of a paid position of leadership and transitioned to running the program based on the Board Members continuing the Sunday School program and volunteers led by Cindy and Dave Cayer assisting the joint Four Church Youth Group Program with the PYF program. Pastor Michelle played an integral part in this transition from guiding the Board during monthly meetings to communicating Sunday School and PYF curriculum content and events in weekly church bulletin updates.

Through the Winter and Spring Semesters, Devin Van Patten, in her paid position, dedicated her efforts toward continuing to build both the Sunday School and PYF programs. Each week she taught Sunday School during Church and led PYF programs on Sunday evenings with continuing declines in attendance. In addition, she brainstormed, organized and led various activities such as the following: encouraging students to attend the Intergenerational Service Epiphany Pageant, leading a Baked Potato Sale to help cover costs for Silver Lake which was later canceled due to only four students registering which was not conducive to developing solid team building activities, organizing the Bible recipient ceremony for one student, leading the PYF as they collected monetary donations and cans of soup for "Souper" Bowl Sunday to donate to Bread for Life, participating in a Community Easter Egg Hunt, participating in Confirmation Sunday, helping to organize Children's Sunday where high school seniors receiving scholarships and graduating were recognized, encouraging PYF to participate in Mystery Dinner, leading an end of the year PYF bowling event.

After SPRINT group explorations, the Church voted to terminate the Director of Christian Education position and to continue both Sunday School and PYF programs through volunteers. A CE Planning Summit was held with plans in place to work over the summer to be ready for Fall Start Up of PCC's all-volunteer program.

Fall Semester Sunday School: Aubrey Quinlan and Linda Lindsay wrote an engaging curriculum where Pastor Michelle was able to connect with weekly Sunday messages. Since there were no volunteers from the Congregation, the four CE Board members rotated as leaders each month to implement the program. According to by-laws, there needs to be two adults at all times. A big thank you to Janet Larkin for volunteering to be the 2nd person (Shepherd) for the month of November. The CE Board members rotated being classroom shepherds along with leaders for the other months. We would like to extend once again our sincere gratitude to the following people: Pastor Michelle for all of her dedicated efforts to guide the board through the transition to an all volunteer program, the members of the Christian Education Board, Diane Pisko, Doris Lipetz, Sue Graham, Christine Moses for their perseverance to continue the Sunday School program, Aubrey Quinlan and Linda Lindsay for their continued assistance with writing the curriculum and shaping the classroom, Janet Larkin for Shepherding in the classroom during November, Cindy Cayer, Dave Cayer, Tony Sennatore, and Barbara Mackay for volunteering with the PYF program. Their hard work, resources and continued dedication provided support for the Board necessary to continue its activities this year and were vital for the continuing success of our mission to prepare and promote a life of Christian faith, learning, and service for our children with a solely based volunteer program.

The Board of Trustees continue to maintain the buildings and property as is our responsibility. Below are some of the items that have been addressed in conjunction with our normal workload.

- The fire suppression system in the kitchen was replaced because it was non-compliant
- The dying Maple tree at the rear of the parsonage lawn was taken down and removed
- Leased a new copier that is faster and has more functions and is less expensive
- The Fire Marshall came in to review our evacuation plan and make suggestions on ways to improve the plan. He also made suggestions on better signage and emergency lighting
- Worked diligently to find and resolve the issue in the kitchen when the main sinks could not be used due to unknown water overflow
- The grease trap and hood were cleaned to keep them in compliance and working properly
- Assisted the Board of Christian Education in getting the CE Classroom ready for Rally Day. Took down the room divider and the old blinds, drapes, and drapery hardware
- Installed new blinds in the room in the lower level that had been the nursery
- The faucet in the downstairs janitor's closet was replaced because it was leaking and could not be repaired
- The parsonage was power washed
- The carpets in the parsonage were stretched and trimmed
- Stained and painted the parsonage deck
- A handrail was installed on the stairs to the parsonage basement
- Replaced the shallow 5" depth sink in the parsonage with a more useful 8.5" depth sink
